

On January 30th, 2012 the Government of Ontario published Ontario's Action Plan To Transform Health Care (Action Plan), to ensure families get the best health care where and when they need it, while ensuring all Ontarians get better value for their health dollars. This was followed by the release of the report from the Commission on the Reform of Ontario's Public Services (the Drummond Report) on February 15, 2012.

This conference will explore recommendations made in both the Drummond Report and the Action Plan that propose a new local integrated health model. This model sets out primary care as the focal point, with access to health services shifted away from emergency rooms towards community care and alternative forms of care.

As we transition towards a patient-centred system, it is essential that funding follow the patient as they move along the health care continuum, while ensuring seamless transitions from one provider to the next.

To achieve this, the government must utilize a strategic systems-approach, driven by evidence and long-term system capacity planning, in coordination with newly introduced funding policy to support access, quality and efficiency.
