Dear Minister Romano,

We recently became aware of the inequity in the ability to renew the Ontario health card online. We ask the government to make the online renewal system equitable and accessible for all OHIP-eligible Ontarians who hold a government-issued driver's licence or photo card.

The ability to renew the Ontario health card online is currently only available to people who can drive, despite the Ontario driver's licence and the Ontario photo card offering identical proof of identity and residency.

It is concerning that those with disabilities are disproportionately affected by this and are required to renew their health card in person. There are many medical circumstances that can prevent people from driving, such as mobility challenges, vision impairment, developmental disabilities, dementia, and epilepsy. There are also conditions like rheumatoid arthritis, which can keep a person from driving while also making them immunocompromised. The government is not thinking about these people and their needs or keeping in mind that these already vulnerable individuals should not be required to expose themselves to further risk by going to crowded ServiceOntario offices.

This discrimination is one example of an inequitable system, which has been laid bare during the pandemic. We call on your government to think about all Ontarians and fix this inequity.

We ask you make the online renewal option available by the end of January to all OHIP-eligible Ontarians with an Ontario driver's licence or an Ontario photo card. This will give people the month of February to renew their expired cards before the renewal deadline of February 28, 2022.
